**ORLEANS PROPERTY OWNERS- YOU MUST PROVIDE A COPY OF THE CURRENT REGISTRATION FOR EACH VEHICLE EVERY YEAR.**

- \* If the vehicle is leased, your name must be on the registration OR provide a copy of the lease agreement listing your name.
- \* Children of real estate taxpayers and residential tenants aged 21 and under must provide a copy of driver’s license showing age. Children over 21 must provide 3 proofs of residency.
- \* Properties deeded to only one name must provide marriage license (or joint tax return) to issue stickers to the spouse’s vehicle.
- \* Only managers of properties listed in an LLC are eligible (see Rules and Regulations for Beach & OSV Sticker Eligibility for more information)
- \* Only trustees of Trusts are eligible (see Rules and Regulations for Beach & OSV Sticker Eligibility for more information)
- \* The burden of proof of eligibility is the responsibility of the applicant.

**YEAR-ROUND ORLEANS TENANTS/RENTERS WHO ARE NOT REAL ESTATE TAXPAYERS:**

Proof of residency is required every year. Your vehicle must be registered in Orleans and is required as proof along with two (2) of the following showing your Orleans residential address:

- \*Current signed yearly residential lease agreement
- \*Current motor vehicle excise tax bill
- \*Current utility bill (in applicant’s name)
- \*Current motor vehicle driver’s license showing Orleans residence as the address
- \*Proof of current listing on Orleans census or voter registration
- \*Jury summons showing your Orleans address

**Check Number**

- Copy of a current, unexpired vehicle registration is required to purchase stickers.
- Stickers are vehicle specific, non-transferable, and must be permanently affixed to the vehicle.
- Purchasing a beach parking pass does not guarantee access to the parking lots when the lots are full
- Residential beach parking stickers are required to park at town landings.
- Residents may not bring household trash to the Transfer Station with a Recycling Only sticker.

**No cash is accepted.** You may pay with a personal check/money order (made payable to “Town of Orleans”). If you wish to pay by credit card, (online transactions require payment by credit card), there will be a 3.99% convenience fee, or \$1.50 fee, whichever is greater.
